DECRETO Nº 060/2021 DE 10 DE JUNHO DE 2021

“Dispõe sobre a adequação da amortização do Déficit Atuarial dos Órgãos Empregadores vinculados ao Instituto de Previdência Municipal de Serra do Salitre-IPMSS”

O **Prefeito Municipal de Serra do Salitre**, Estado de Minas Gerais, no uso de suas atribuições legais, constantes na Lei Orgânica Municipal promulgada em 31 de março de 1990, demais atualizações posteriores.

CONSIDERANDO o disposto no inciso VIII, Art. 75 da Lei Municipal n.º 559 de 27 de dezembro de 2005, com redação dada pela Lei Municipal n.º 718 de 28 de novembro de 2011;

CONSIDERANDO a reavaliação atuarial de 2021 realizada pelo Instituto de Previdência Municipal de Serra do Salitre;

DECRETA:

Art. 1º - Fica adequado o Anexo Único da Lei Municipal n.º 559 de 27 de dezembro de 2005, com a seguinte redação:
